Primary Duties of a 310T or 421A Heavy Equipment Technician (Mechanic):

- Diagnose Mechanical & Electrical Issues
- Identify faults in systems such as hydraulics, electrical, air brakes, transmissions, and diesel engines.
- Use diagnostic tools (e.g., OEM software, multimeters, scan tools) to assess performance issues.
- Perform Repairs & Rebuilds
- Repair or replace defective parts like engines, gearboxes, differentials, final drives, fuel systems, hydraulic components, undercarriage, and more.
- Rebuild or overhaul major systems, including engines and transmissions.
- Routine Maintenance
- Perform scheduled servicing on dozers, excavators, loaders, graders, haul trucks, and other equipment.
- Change fluids, filters, grease fittings, inspect hoses, belts, brakes, and other wearable components.
- Field Service Repairs
- Travel to job sites to conduct emergency repairs or inspections on downed equipment.
- Operate service trucks outfitted with cranes, welders, and tooling.
- Hydraulic System Maintenance
- Inspect and repair hydraulic pumps, valves, cylinders, and hoses.
- Diagnose pressure and flow issues using hydraulic test equipment.
- Electrical System Diagnostics

- Troubleshoot starters, alternators, sensors, controllers, and CAN-bus wiring systems.
- Work with complex electronic controls on newer Tier 4 and Stage V engines.
- Documentation & Compliance
- Maintain detailed service records, inspection reports, and repair documentation.
- Comply with MTO regulations and company safety policies (including CVOR standards).

- Advise on equipment life cycles, preventative maintenance plans, and parts ordering.
